## Closed-Circuit Television System License

Thank you for your interest in Geddes Productions, LLC's video/DVD **BIOLOGICAL NURTURING@: LAID-BACK BREASTFEEDING FOR MOTHERS** with Suzanne Colson for your closed circuit television system. Copyright law requires we must actively protect our copyright or forfeit it by neglectful action. Geddes therefore appreciates your honesty in approaching us in this manner. To that end we are working to make this process as easy and affordable for all involved.

Before we can grant you permission to use the video/DVD, the following conditions must be met:

1. We expect that you have already purchased the video/DVD in its entirety. If you do not already own the video/DVD you will need to purchase it. If you have previously purchased the video/DVD, please provide proof of purchase (for example, receipt or name and date of conference where it was purchased). The cost of the DVD is separate from the License Fee.
2. You must agree to play the video/DVD in its entirety to include all Disclaimers, Company and Copyright information from beginning to end on your system.
3. A License Agreement will be drawn up and signed by you and Geddes Productions, LLC outlining the details of this license arrangement and the fee paid before the video/DVD is shown.
4. This arrangement is for your institution/facility's Closed Circuit Television System only and does not allow copies to be made for any other person, institution, facility or purpose. This arrangement is NOT for use on the Internet/intranet nor may it be used if your system's collection of programs including this video/DVD is re-recorded in any way (audio or video). Such use requires a separate agreement.

If your intent is to make a protection copy or transfer the video/DVD to another format that holds other tapes/programs, then the Closed Circuit System Limited License Agreement will apply to the granting of this privilege. The following conditions must also be met:

1. Transfers must be made from a high quality original to preserve the quality of the picture and therefore the reflection on our reputation as a filmmaker.

2. A one-time Closed Circuit System Limited License Fee of \$200.00 will be paid per video/DVD. This fee will exist to cover the life of the purchased video/DVD and includes limited license to broadcast only within your own closed circuit system.
3. A contract will be drawn and signed by your institution and Geddes Productions, LLC outlining the details of this arrangement and fees paid before copies or transfers are made.
4. This arrangement is for closed circuit television systems only and does not allow copies to be made for use outside the institution premises. This arrangement is NOT for use on any website or any Internet use.
5. The video/DVD must be copied in its entirety including all beginning titles and ending credits without editing of any kind. (This preserves the copyright).

# CLOSED CIRCUIT SYSTEM LIMITED LICENSE AGREEMENT

This \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_, Geddes Productions, LLC (“Geddes”) grants \_\_\_\_\_ (“Licensee”) the limited right to show and, if needed, make a protection copy for use in its closed circuit system and keep the original of the following purchased video/DVD(s):

**LICENSE TERMS:** Licensee is granted a limited, non-exclusive license to use the above listed video(s)/DVD(s) within a closed circuit system. You may not use the video/DVD on the Internet, within Licensee’s own created videos/DVD nor allow audio or video recording of any presentation that includes the video/DVD. Licensee may not make copies for any use by others. Licensee will inform all audiences in any bibliography of where they can obtain the video/DVD from which clips were obtained. This License Agreement covers only the use of footage within the film *Biological Nurturing®: Laid Back Breastfeeding for Mothers* and does not grant any permissions or usage for the term *Biological Nurturing®*.

**TERMINATION:** This License is effective until terminated. This License will terminate immediately without notice from Geddes if Licensee fails to comply with any of the provisions of this Agreement. Licensee may also terminate this License at any time by giving notice of termination to Geddes. Upon termination Licensee must destroy the video/DVD and all copies in existence including any in presentations or may return the copies to Geddes.

**LIABILITY:** Geddes’ liability to Licensee (if any) for actual direct or incidental damages for any cause whatsoever and regardless of the form of the action, will be limited to, and in no event shall exceed, the amount originally paid Geddes for the License of the video/DVD.

**Licensee is liable to Geddes in the sum of \$200 for each copy of a video/DVD listed in this Agreement obtained by any third party from Licensee. Licensee must use all due care to assure third parties do not acquire or use the videos/DVD purchased by Licensee under this Agreement.**

Geddes retains ownership of all copies of videos/DVDs and documentation copyrights, no matter in what form they are or the media in which any copies reside. Licensee assumes sole responsibility for the installation, use and results obtained from use of the video/DVD or authorized copies.
