The embedded information will flash discreetly at the lower left corner of the clip with the words "Permission to (your name) © (yr of DVD) (name on copyright) www.geddesproduction.com." The License Fee includes the cost of producing the clip.
3. You may not make the clip yourself in any way.
4. If you do not want the embedding then you must agree to play the video/DVD in its entirety to include all Disclaimers, Company and Copyright information from beginning to end within your Online Course and still pay the fee for this permission.
5. A contract will be drawn up and signed by you and Geddes Productions, LLC outlining the details of this arrangement and fee paid before the clips are made. Clips will either be emailed to you or posted on a retrievable sight and you will be notified where to upload them.

6. This arrangement is for your use only and does not allow copies to be made for other any other person or course other than as stated on the clip.

TERMINATION: This License is effective until terminated. This License will terminate immediately without notice from Geddes if Licensee fails to comply with any of the provisions of this Agreement.
